Massachusetts State Police recover submerged vehicle at Boston pier with two victims inside including woman from New Bedford

Massachusetts State Police divers, assisted by a Boston Fire Department diver, located and recovered a vehicle with two occupants from the Reserved Channel leading to the harbor in the Boston Seaport.

The recovery of the vehicle and the victims, one of whom is 21-year old Tatiana Morales from New Bedford, both deceased.

At approximately 12:30 as part of an ongoing investigation, members of Massachusetts State Police Troop F responded to Black Falcon Avenue, between the Black Falcon Terminal and 88 Black Falcon Ave., after developing information that a sport utility vehicle went into the water at that location earlier this week. The Massachusetts State Police Underwater Recovery Unit, the State Police Detective Unit for Suffolk County, Boston Police, Boston Fire, and Massport Police also responded.

A Boston Fire Department diver was the first to dive the area and located the vehicle in about 40 feet of water, approximately 15 feet out from the pier. The BFD diver marked the location, surfaced and notified MSP divers who were arriving on scene. Three MSP divers then dove on the vehicle site and determined there were two deceased victims inside.

MSP divers were able to extricate the female victim and bring her body to shore. The male victim could not be extricated from the vehicle while underwater, so divers hooked tow cables to the entire vehicle and a truck winched it out. The male victim was recovered from the vehicle once it was on land.

The cause and manner of the deaths is subject to the ongoing investigation.

LaFrance Hospitality to pay \$20,000 for Americans with

Disabilities Act violation at New Bedford Marriott Fairfield hotel

LaFrance Hospitality, operator of 14 hotels in New England, has entered an agreement under Title III of the Americans with Disabilities Act (ADA) to resolve allegations that the showers in the accessible rooms of their New Bedford Marriott Fairfield hotel were inaccessible to persons with disabilities.

LaFrance Hospitality failed to install permanent shower seats on the wall in their roll-in showers at the New Bedford Marriott Fairfield as is required by the ADA. Instead, non-fixed seats were placed in each roll-in shower. When a woman with a mobility impairment used the non-fixed shower seat it collapsed, and the woman fell. The fall resulted in the woman requiring emergency services and an overnight stay at a local hospital for her injuries.

Under the agreement, LaFrance Hospitality will ensure all showers in accessible rooms in all 14 of its hotels meet ADA standards, including installation and positioning of shower seats, grab bars, and shower spray units. LaFrance Hospitality also will pay the woman \$20,000 in compensation.

"Meeting the requirements of the ADA means individuals with mobility impairments should never have to question whether the hotel they are staying in will provide safe and accessible rooms," said United States Attorney Andrew E. Lelling. "We commend LaFrance Hospitality for working cooperatively with us to meet the standards of the ADA moving forward."

This year marks the 30th Anniversary of the Americans with Disabilities Act. The Justice Department plays a central role in advancing the nation's goal of equal opportunity, full

participation, independent living, and economic selfsufficiency for people with disabilities. The Justice Department will continue to use its enforcement and technical assistance tools to eliminate unlawful discrimination against individuals with disabilities.

This case was handled by Assistant U.S. Attorney Gregory Dorchak of Lelling's Civil Rights Unit.

The final budget meeting and vote is on Aug 24.

Due to COVID-19, New Bedford City Council meetings are held on Zoom which makes attendance very easy. Councilor Dunn has stated, "My absence has no impact on my ability to effectively represent my constituents as we navigate the budget process." Councilor Coelho hasn't responded to an email request but announced her retirement shortly after getting elected.

The FY2021 budget review comes during a COVID-19 pandemic, shrinking revenues, and mayor requested cuts to the police and fire departments. The budget will determine the need for future property tax increases and fees, so the City Council's role in the budget process is considered the single most important job city councilors have.

One of the New Bedford Black Lives Matter leaders arrested in connection to double shooting

Two men were arrested for the July 26 shooting of two men at Petro Mart on Coggeshall Street in New Bedford to include a leader in the New Bedford Black Lives Matter movement.

According to New Bedford police, 24-year old Tyrell Woodis-Pina of Fairhaven and Giovanni Vale-Valentin of New Bedford have both been charged with discharging a firearm along with numerous weapons-related offenses. Another suspect, 23-year old Brian Ortiz of 2110 Phillips Rd. Apt. #19 in New Bedford, remains at large. A warrant is out for his arrest on numerous firearms-related charges.

Tyrell Woodis-Pina, a resident of Fairhaven, is one of the two people that manage the New Bedford Black Lives Matter Facebook page with over 1,600 followers and has been at many of the Black Lives Matter protests in New Bedford earlier this year. Here's Tyrell Woodis-Pina live on the Black Lives Matter Facebook page on July 23rd complaining that the police arrested his pregnant girlfriend.

Woodis-Pina's Facebook page shows him at a Black Lives Matter rally in New Bedford during the day of June 2nd:



According to New Bedford records, Woodis-Pina was one of two people arrested for disorderly conduct the night of June 2nd after protesters illegally marched down Route 18.

Earlier in the day on June 2nd, after Black Lives Matters protestors shut down the New Bedford/Fairhaven bridge for a

short time, Woodis-Pina threatened physical violence on a New Bedford Guide reporter (me) while simply covering the protest.

Woodis-Pina messaged New Bedford Guide to remove some protest photos that were sent to us and posted. He sent us a private message on May 30:

Woodis-Pina messaged us in October, telling us that his uncle shot him.

Since the death of George Floyd the vast majority of Black Lives Matters protesters in New Bedford and throughout the south coast, Massachusetts area have been peaceful. Black Lives Matter groups in places like New Bedford are unofficially organized and anyone can step up to be a leader. According to the Black Lives Matters New Bedford's page transparency, two people run the page and since Tyrell Woodis-Pina went live from the page, he is one of them. While Tyrell Woodis-Pina is not the leader of the New Bedford Black Lives Matter movement, he is a leader in the movement with over 1,600 Facebook followers and active in the protests.

There will be detour signage and traffic controls in place.
- The contractor (Bay State Wind Water) is scheduled to replace water meters at various NBHA locations.
- Due to ongoing construction at the High Hill Reservoir residents may experience discolored water. The water is safe, and the discoloration will be temporary. We recommend allowing the water to settle for a few hours and then flushing your service line by letting the bathtub run for a few minutes until the water clears.

New Bedford School Committee unanimously approves hybrid plan

The New Bedford School Committee approved a fall reopening plan with a phased-in approach prioritizing the district's high needs students and those in transition grades. Recommended by Superintendent Thomas Anderson, the 3-phase hybrid plan will go into effect August 31, 2020. "We will use a hybrid plan, which incorporates distance learning and cohorts of students who will be in classrooms 2 days per week and participating in a strict distance learning platform 3 days per week for a full 5 days of learning each week," he said.

Of the hybrid plan, ex officio chair of the committee, Mayor Jon Mitchell said, "It is important for families, students, and educators to know that as we move ahead, we must and will continue to monitor the state of the virus and any potential impacts on the operation of the school district. Any adjustments or changes will be based on science, data, and the best public health guidance available. This plan for the school year is a roadmap that will allow families and teachers to plan. I appreciate the work of the superintendent and the team comprised of educators from across the district who provided valuable feedback to the reopening planning process, and the families of New Bedford students who shared their thoughts and ideas with the district."

New Bedford Public Schools will reopen in three phases with

all students divided into three cohorts.

Phase I begins on August 31 when all NBPS staff report to work for staff training and professional development.

Phase II begins on September 16 when Cohort A, which will consist of students based on their learning needs (i.e., spend less than 40% in general education, level 1 English Language Learners, McKinney-Vento/homeless or extenuating circumstances) returning to school for in-person instruction 5 days a week. Cohorts B and C, which will consist of all other students, will be all accessing the distance learning platform.

Phase III begins on October 5 when Cohort B, which will consist of Transition Grades Pre-K, K, 6 and 9 returning for a hybrid schedule of classroom and distance learning. Split into two subgroups, Cohort B1 will be in the classroom for inperson instruction on Mondays and Tuesdays, with distance learning on Wednesdays, Thursdays and Fridays. Cohort B2 will be in the classroom for in-person instruction on Thursdays and Fridays, with distance learning on Wednesdays, Thursdays and Fridays.

Phase III continues on October 19 with Cohort C, which consists of all remaining students returning for a similar schedule: Cohort C1, In-person on Mondays and Tuesdays, with Distance Learning on Wednesdays, Thursdays and Fridays. Cohort B2 will be in the classroom for in-person instruction on Thursdays and Fridays, with distance learning on Mondays, Tuesdays and Wednesdays.

Students' schools will be contacting families directly with schedule details and information related to specific health precautions. Additional information regarding bus transportation changes will be forthcoming. As a reminder, parents have the right to choose between the hybrid and distance learning options. The district is developing a

commitment form for parents who elect to enroll their child in 100% distance learning.

Implementation of the three phases of the reopening plan will be determined by the transmission rate of COVID19 (currently 2.2% in New Bedford and less than 2.0% state average) and facility readiness, including corrective actions for identified rooms.
