### Kingston Police arrest 3 after allegedly beating elderly man with a 2×4 piece of lumber

"Shortly after midnight going into today 8/4/23, the Kingston Police Department received a call for a party that had been seriously assaulted.

The injuries were caused when the victim was beaten by multiple suspects and struck multiple times with what appeared to be a 2×4 piece of lumber. The victim was transported to the hospital with significant injuries, including what appears to be a serious head injury and several broken bones. The victim remains at the hospital at this time.

After an extensive investigation throughout the day, members of both the patrol and detective's division were able to identify the suspects and arrest three adult males at three separate residences. One party was arrested without incident in Carver. Two other suspects who were at their respective addresses failed to answer the door for our officers and appeared to be home and evading contact with law enforcement. Subsequently, warrants were requested and granted by Plymouth District Court.

Residents of a small residential street off of Main Street may have seen several cruisers in the area as well as a combination of plain clothes and uniformed officers surrounding two nearby homes at approximately 7pm today. Officers utilized a shield and loudly announced their presence.

At the first residence, officers informed the suspect of the warrant and ordered him to open the door on several occasions.

The suspect failed to do so and the door was forcibly opened by our detectives. The resident was then taken into custody without incident. Upon the forcible entry into the first residence, the other suspect then exited his home and was taken into custody without incident.

### All three suspects are charged with:

- Assault and Battery with a Dangerous Weapon on a victim 60+
- Assault and Battery resulting in Serious Bodily Injury on victim 60+
- Assault and Battery on a victim over 60+ years old
- Assault and Battery with a Dangerous Weapon
- Assault and Battery with a Dangerous Weapon With Serious Bodily Injury
- Assault and Battery

The suspects will be arraigned on Monday morning at Plymouth District Court and are assumed innocent until proven guilty."-Kingston Massachusetts Police Department.

Candidates are required to sign up and will be given an information packet that contains the Election Calendar and nomination papers. Before issuance of nomination papers, the candidate must sign a statement containing the person's name, address, and the office the person intends to be a candidate. Anyone other than the candidate must present a signed authorization to secure papers on their behalf. Candidates must obtain 50 certified signatures, per MGL 53 9A, to be eligible to appear on the Preliminary Ballot scheduled for October 3rd.

The Municipal Election is scheduled for Tuesday, November 7, 2023. In the Preliminary Municipal Election, New Bedford voters will be casting their votes for Mayor, Assessor-At-Large, School Committee, Councilors-At-Large, and Ward Councilors. Guatemalan living in Massachusetts convicted of strangulation, Assault &

### Battery, sentenced

"Defendant previously convicted of strangulation/suffocation and assault and battery.

A Guatemalan man residing in Framingham has been sentenced in federal court in Boston for illegally reentering the United States after deportation.

Carmen Jimenez-Cruz, 42, was sentenced on May 11, 2023 by U.S. District Court Judge Angel Kelley to one year and one day in prison followed by one year of supervised release. Jimenez-Cruz will be subject to deportation proceedings upon completion of his sentence. On Jan. 24, 2023, Jimenez-Cruz pleaded guilty to illegal reentry.

In May 2013, Jimenez-Cruz was encountered by federal immigration authorities after he illegally crossed the Mexican border into Texas without being admitted by an immigration officer. He was removed from the United States in June 2013. One month after his removal, Jimenez-Cruz illegally reentered the United States and, in July 2013, he was again encountered by federal immigration authorities in Texas after having entered the United States without inspection. He was removed from the United States shortly thereafter in July 2013.

On an unknown date and place, Jimenez-Cruz illegally reentered the United States again. In April 2019, federal immigration authorities located Jimenez-Cruz at the Middlesex County House of Correction where he was being held pretrial on unrelated state charges. According to court records, in May 2022, Jimenez-Cruz was convicted of strangulation/suffocation and assault and battery on a family/household member and was sentenced to an 11-month split sentence followed by probation until May 2023. Upon completion of his sentence, Jimenez-Cruz was released from state prison.

Jimenez-Cruz was later located in September 2022 after being

identified as a passenger during a motor vehicle stop in Framingham. Jimenez-Cruz was taken into custody and fingerprints obtained during his booking process were confirmed as an identical match to a prior removal verification document.

United States Attorney Rachael S. Rollins; Todd Lyons, Field Office Director, Boston, U.S. Immigration and Customs Enforcement's Enforcement and Removal Operations; and Framingham Police Chief Lester Baker made the announcement. Assistant U.S. Attorney Suzanne Sullivan Jacobus of Rollins' Major Crimes Unit is prosecuted the case." -Massachusetts Department of Justice.

### 6-year old struck and killed by Sysco tractor-trailer in Andover

On Tuesday at approximately, 5:00pm the Andover Police and Fire Departments and EMS received reports of a pedestrian versus tractor-trailer accident downtown.

Upon arrival at Elm Square at the intersection of Elm and Main streets, first responders learned that a Sysco tractor-trailer had struck a 6-year-old child in a crosswalk. The gender and name were withheld.

Andover Police Chief Patrick Keefe said that several other people in the area at the time of the crash were taken to a local hospital as a precautionary measure in spite of the fact they were not struck. Keefe said the driver of the Sysco truck did stop and immediately cooperated with police. Sysco also responded to this crash in a statement, writing "The Sysco family is heartbroken to learn of the tragic death of a pedestrian today in an incident involving one of our vehicles from Sysco Boston. We offer our condolences and prayers to the individual's family and community and are grieving with them for their loss."

Multiple eyewitnesses on the scene reported that this particular intersection was incredibly busy and dangerous. For several hours Massachusetts State and Local Police remained on the scene collecting data and had the truck towed. The accident remains under investigation.

### Truck barrels through Massachusetts gas station, left dangling over retaining wall

It's a minor miracle that no staff, customers, and pedestrians were struck and injured, or worse, killed and there was no fire or gas leak.

Locals mentioned that the poorly designed roundabout was a common site of minor accidents and felt that it was only a matter of time before a major accident ocurred.

# Massachusetts sex offender previously convicted of rape, arrested for possessing child pornography

"A Chelsea man was arrested yesterday for possessing child sexual abuse material (CSAM).

Lasall Johnson, 54, was charged with possession of child pornography. Following an initial appearance in federal court in Boston yesterday afternoon before U.S. District Court Magistrate Judge Judith G. Dein, Johnson was detained pending a hearing scheduled for March 23, 2023.

According to the charging documents, an investigation into suspected CSAM being exchanged on an online peer to peer file sharing network identified a user located at Johnson's residence. It is alleged that, during a subsequent search of Johnson's address, six electronic devices were seized that were found to contain several images and videos depicting CSAM.

In 1989, Johnson was convicted in Norfolk County Superior Court of two counts of assault to rape, for which he received a 20-year state prison sentence with two years committed and the balance suspended for 18 years. As a result of those convictions, Johnson is a Level-2 registered sex offender.

Due to Johnson's prior convictions, the charge of possession

of child pornography provides for a mandatory minimum sentence of 10 years and up to 20 years in prison, at least five years and up to a lifetime of supervised release and a fine of up to \$250,000. Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and statutes which govern the determination of a sentence in a criminal case.

United States Attorney Rachael S. Rollins; Michael J. Krol, Special Agent in Charge of Homeland Security Investigations in New England; and Chelsea Police Keith Houghton made the announcement today. Assistant U.S. Attorney Suzanne Sullivan Jacobus of Rollins' Major Crimes Unit is prosecuting the case.

This case was brought as part of Project Safe Childhood, a nationwide initiative to combat the growing epidemic of child sexual exploitation and abuse, launched in May 2006 by the Department of Justice. Led by the U.S. Attorneys' Offices and the DOJ's Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute individuals who exploit children, as well as identify and rescue victims.
