20 years running, New Bedford is the nation's highest-grossing commercial fishing port

At one point in 1857, New Bedford was the richest city per capita in the world because of fishing, whaling to be precise. Back then there were 329 vessels worth over \$12 million. While whaling began to decline from that point on, New Bedford went on to textiles and lighting, before returning to the bounty of fishing again.

The National Marine Fisheries Service released its annual report yesterday and for the 20th year in a row, New Bedford is the nation's highest-grossing commercial fishing port with an astounding haul worth \$451 million, up from \$431 million in the previous year.

How far ahead is New Bedford when compared to other fishing ports around the world? No one is even close. Second place went to the Port of Naknek, Alaska, which landed a total catch that was "only" worth \$289 million. The popularity of TV shows has shined light on Dutch Harbor, but that port only brought in a total catch valued at only \$190 million, garnering them 3rd place.

What makes the first place ranking even more special is that New Bedford isn't a top winner when it comes to volume. In fact, we didn't even make it into the top ten: New Bedford ranked 14th place with a total volume of 116 million pounds. Where we stand out is in the value, much of which comes from scallops.

New Bedford Mayor Jon Mitchell said "During the pandemic, we have strived to keep our waterfront workforce safe, and so it

is encouraging now to see seafood businesses alive with activity as the pandemic begins to subside."

Also proud was Senator Warren for her role: "The fishing and seafood industry are a key part of the Commonwealth's history, economy, and future, and I and my Massachusetts colleagues worked hard to provide them with federal COVID relief and we will continue to support our fishing community as we recover from this pandemic."

Massachusetts State Police, Fire Marshal announce fireworks enforcement efforts have begun

State Fire Marshal Peter J. Ostroskey and Massachusetts State Police Colonel Christopher Mason announced today fireworks enforcement efforts have started. The State Police Bomb Squad is part of the Fire and Explosion Investigation Unit (F&EIU) assigned to the Office of the State Fire Marshal, which has already started working with local police and fire departments to enforce the fireworks laws and intercept fireworks being brought into the state illegally.

"It is illegal to bring fireworks into Massachusetts, even if they were legally purchased elsewhere," said State Fire Marshal Ostroskey.

The State Police Bomb Squad had a 63% increase in response to fireworks calls in 2020 over 2019. During the F&EIU 2020 fireworks enforcement operation, there were 47 criminal summonses issued over a 4-day period. This year's enforcement operation has already started and will last longer.

"In addition to special enforcement efforts to intercept fireworks coming into Massachusetts, troopers and local police will seize illegal fireworks they find during routine traffic stops," said Colonel Mason. "We don't want a repeat of the huge increase in resident complaints we experienced last year."

In communities throughout the Commonwealth, there has been a significant rise in resident complaints regarding fireworks. Complaints to the Boston Police Department increased 1,518% from 1,504 in 2019 to 21,346 in 2020, and in calendar 2020,

the Springfield Police Department received 3,504 calls for fireworks. The peak was between May 1 and July 31 when 3,345 calls were received.

Fireworks complaints to the Lawrence Police Department increased 409% in 2020 from 2019, and there were 159 fireworks complaints in 2019 and 810 in 2020. In the summer period (May 1 — August 31), fireworks complaints increased by 420% from 148 in 2019 to 769 in 2020. In Brockton, resident complaints about fireworks to the Brockton Police Department increased 611% from 209 in 2019 to 1,486 in 2020.

"There will be supervised displays of fireworks this year unlike last year, so we encourage you to leave the fireworks to the professionals," said Fire Marshal Ostroskey. "Fireworks are illegal because they are dangerous. Fires started by fireworks in Massachusetts increased 180% in 2020 from 2019."

In the past decade (2011-2020), there have been 941 major fire and explosion incidents involving illegal fireworks reported to the Massachusetts Fire Incident Reporting System (MFIRS). The incidents caused 12 civilian injuries, 42 fire service injuries, and an estimated dollar loss of \$2.1 million, which is high considering most fireworks fires are outdoor brush fires.

Additionally, 32 people were treated at Massachusetts emergency rooms for severe burn injuries from fireworks (burns covering 5% of more of the body) according to the Massachusetts Burn Injury Reporting System. This does not include visits to hospital emergency rooms for eye injuries, amputations, puncture wounds or smaller burns. Forty-one percent (41%) of fireworks-related burn injuries reported by hospitals to the Office of the State Fire Marshal in the last 10 years (2011-2020) were to children under age 18. Twenty-six percent, (26%) were children under age 10.

UMass Dartmouth to reinstate women's tennis and women's swimming & diving

Due to changing demographics within the UMass Dartmouth student population and given the current collegiate sports environment, the University has revisited its July 2020 decision to discontinue eight of the University's 25 intercollegiate athletic programs — women's equestrian, men's golf, men's lacrosse, co-ed sailing, men's and women's swimming and diving, and men's and women's tennis.

In the first of several anticipated changes as part of an overall strategy to better align athletic participation opportunities for women with the female undergraduate

population, UMass Dartmouth is reinstating Women's Tennis and Women's Swimming and Diving as varsity intercollegiate programs, effective immediately.

The University's July 2020 decision was based on outside reviews of the University's intercollegiate athletics program to provide the best possible competitive and co-curricular experiences for student-athletes. The reviews analyzed major aspects of the current Department of Athletics & Recreation structure and metrics such as available resources, gender equity, enrollment, and facilities to formulate a long-term strategic plan for athletic competition at UMass Dartmouth.

"We will move quickly over the next week to meet with studentathletes and staff to ensure our intent is clear. Our commitment to enhance the quality and increase the number participating in our tennis and swimming/diving programs is a priority," said Athletic Director Amanda Van Voorhis.

With this decision, the University will work to address the needs of student-athletes that will compete in the reinstated programs, including medical clearance, training, and scheduling contests for fall 2021. The Department of Athletics & Recreation and Human Resources are currently working to address coaching needs to ensure student-athletes in these programs have the necessary level of support. Student-athletes from the tennis and swimming and diving programs have been contacted by Van Voorhis via email. A virtual meeting will be scheduled to allow student-athletes to ask questions, as well as discuss the details surrounding the transition back to varsity programs.

"Providing opportunities for student-athletes is always a priority," said David Gingerella, Vice Chancellor for Administration & Finance at UMass Dartmouth. "The University is committed to making this transition as smooth as possible and commit the necessary resources to allow our students to succeed both on and off the playing field."
