City of New Bedford to Lift Mask Policy in Municipal Buildings

With the recent precipitous drop in COVID-19 transmission in New Bedford, Mayor Jon Mitchell has decided to lift the policy requiring the use of masks in the public areas of municipal buildings, such as City Hall and public libraries. The mask policy will be lifted as of 4 p.m. Friday, Feb. 18. Mayor Mitchell is grateful to everyone who has observed the mask requirement since its establishment by executive order in August 2021.

COVID-19 cases in New Bedford have fallen dramatically over the past five weeks. The City hit its peak of daily cases on Jan. 7, when 562 cases were reported over the previous 24-hour period. On Tuesday, Feb. 15, just 17 cases were reported in the previous 24 hours, a 97-percent drop from the peak.

The New Bedford Health Department is continuing with other pandemic response efforts, including the promotion of COVID-19 vaccinations and boosters, which have proven extremely effective at preventing severe COVID outcomes. The Health Department also is continuing to monitor transmission risk and the emergence of new variants that could require additional safeguards.

Massachusetts officials will allow statewide school mask mandate to expire

After consulting with medical experts and state health officials, the Commissioner will not renew the state mask requirement after it expires on February 28, 2022.

The decision was made in consultation with infectious disease physicians, the Massachusetts Department of Public Health, and other medical experts. Vaccinations are the best protection against COVID-19, and Massachusetts has among the highest vaccination rates of young people and is a national leader in overall vaccination. In Massachusetts, 52 percent of all individuals who are fully vaccinated have received a booster dose, compared to 42 percent of the national population.

Effective Monday, February 28, the DESE mask requirement will

be lifted statewide. The Commonwealth's high vaccination rates and widespread availability of COVID-19 testing for school personnel and students support this decision.

Masking continues to be required on all school buses, per federal order.

More than 40 schools have already received approval from DESE to remove the mask requirement. With the removal of the statewide mask requirement, additional schools no longer need to apply. With the lifting of the statewide mask requirement, school districts no longer need to request a waiver from DESE to remove masks in school buildings where 80 percent of staff and students are vaccinated. Masking will be a community choice in schools across the Commonwealth, regardless of vaccination rates within a school; however, a school district could establish a local requirement.

DESE continues to recommend that districts and schools adopt a layered approach to mitigate the spread of COVID-19 in school settings. DESE and DPH continue to strongly urge all eligible individuals to receive the COVID-19 vaccine and booster and continue to support schools with vaccination clinics. Other mitigations include participating in the statewide COVID-19 testing program, maintaining good hand hygiene practices, and staying home when sick.

"IS THERE A WAY I COULD POST THIS ANONYMOUSLY PLEASE. I WOULD Love to know what people thought I should have done. But people are so mean. Could we not put my name please?

Only 1 school decided that they wanted my son in school. They didn't care that my house was sick or that their father was damn near ready for the emergency room.

That school DECIDED TO REPORT ME for school negligence and sent an investigator to my house to check on the well-being of my children. Keep in mind my youngest has a heart defect and we literally are just trying to do what's best for everyone including ourselves.

accept and report UNEXCUSED absences and not tell them THEY HAD AN ACTUAL DR NOTE.
