# New Bedford Police foot pursuit leads to seizure of loaded .40 caliber Glock, ammo and arrest of two, including juvenile

New Bedford Police narcotics unit took a loaded .40 caliber Glock 27 firearm with five (5) rounds of ammunition in the magazine off the street Tuesday, Sept. 11 and arrested two people after a brief vehicle chase and subsequent foot pursuit into a wooded area in the 400-block of Potter Street.

While patrolling, detectives in the Narcotics Unit approached a vehicle that was occupied in the area of Carriage Drive and Bryant Lane. As detectives approached the vehicle, the occupants started to close their windows and maneuver within the vehicle. The actions of the occupants caused detectives to suspect they were attempting to conceal a potential weapon.

The vehicle would then flee and a brief vehicle pursuit ensued, which would end in the 400-block of Potter Street, where one of the occupants would flee on foot in a wooded area. A foot pursuit ensued and the suspect would subsequently surrender. A loaded .40 caliber firearm was located in the area where the suspect had been running.

With assistance from patrol units, police arrested the suspect, a juvenile, on charges of carrying a loaded firearm and on a warrant.

The driver of the vehicle, Kevin A. Zelaya-Ayala, 19, of Sawyer St., New Bedford, was charged with two counts of failure to stop for police and driving with an obstructed window.

The arrests were made at 7:32 p.m. Tuesday, Sept. 11.

Juan C. GONZALEZ has been classified as a Level 3 Sex Offender by the Massachusetts Sex Offender Registry Board. In 1989, GONZALEZ was convicted of Rape of a Child With Force in Bristol Superior Court and received a 15 year sentence. This case involved repeated sexual assaults over several years in Taunton beginning when the victim was approximately 5 years old. GONZALEZ has continually failed to abide by the conditions of his Sex Offender Registration requirements and has previously been convicted on 4 separate charges of Failure to Register as a Sex Offender beginning in 1998. GONZALEZ has a lengthy criminal record which includes convictions for Masked Armed Robbery, Carry Firearm (2 cts), Assault & Battery and Threatening. He has utilized numerous aliases in the past and has ties to Taunton, Boston, and New York. Warrant #1308CR000915, 1208CR000292, & 1108CR001682 exist for GONZALEZ with Nationwide Rendition authorized.

1. JUAN C. GONZALEZ, 57, classified as Level 3 Sex Offender by the Massachusetts Sex Offender Registry Board, wanted for four counts of failure to register as a sex offender as required by law. GONZALEZ was convicted of rape of a child with force in 1989 in connection with repeated sexual assaults of a child in Taunton, beginning when the child was 5 years old. GONZALEZ

has additional convictions for masked armed robbery, unlawful carrying of a firearm, assault and battery, and making threats. He is Hispanic, with black hair and brown eyes, 6'3" tall, weighs about 200 lbs., and has a tattoo on his upper right arm and scars on his left shoulder, back, abdomen, and hip. GONZALEZ has used numerous aliases in the past, including JUAN GONSALVES, WILLIE GONSALVES, ALEX GUERRERO, JUAN GONZALEZ IRIZARRY, AND JASON DIAZ. He has ties to Taunton, Boston, and New York.

The victim in this case was a 12 yr old boy who met JIMENEZ via an on-line chat room. JIMENEZ convinced the boy to meet him under the guise of playing video games and then sexually assaulted him. JIMENEZ is currently in Violation of his Lifetime Sex Offender Registration requirements and has further not adhered to the conditions of his Probation on the above conviction. JIMENEZ is a former MSP Most Wanted Sex Offender who was captured in 2013 and he has ties to Holyoke and Springfield. Warrant #0579CR000257 issued out of Hampden Superior Court exists for JIMENEZ with Nationwide Rendition authorized.

**3. ROBERTO JIMENEZ JR.**, 35, classified as a Level 3 Sex Offender by the Massachusetts Sex Offender Registry Board, currently in violation of his Lifetime Sex Offender Registration requirements and of his probation conditions stemming from a 2006 conviction. In that case, JIMENEZ was

convicted of two counts of rape of a child under 16 and a single count of indecent assault and battery on a child under 14 in connection with an assault in Springfield. The victim in that case was a 12-year-old boy whom JIMENEZ met in an online chat room and persuaded the boy to meet him under the guise of playing video games. JIMENEZ is Hispanic, 5'8" tall, about 150 lbs., with brown hair and brown eyes. He has used the aliases ROBERT JIMENEZ, "DILL," AND "DEE." JIMENEZ is a repeat member of the MSP's Most Wanted Sex Offenders list, having been previously added to the list and captured in 2013 prior to violating his registration requirements again.

Angel M. ROSADO has been classified as a Level 3 Sex Offender by the Massachusetts Sex Offender Registry Board as a result of his 1991 conviction in Suffolk Superior Court for Rape of a Child Under 16 With Force, Assault & Battery With a Dangerous Weapon and Robbery. This conviction stems from an incident in 1990 when ROSADO and a co-defendant dragged a female under a state owned bridge in Boston, struck her with a large object and then took turns raping her. ROSADO received an 8-12 year prison sentence and has repeatedly violated his Sex Offender Registration requirements. He has previously been convicted on 3 separate counts of Failure to Register as a Sex Offender and has an extensive criminal history in Massachusetts, Pennsylvania, New York and New Jersey. ROSADO is possibly Homeless and has tattoos throughout his body including teardrops under his left eye and a visible tattoo on the right side of his neck. Five Massachusetts arrest warrants for a variety of charges exist for ROSADO including warrant #1401CR002609 for Failure to Register as a Sex Offender/Subsequent Offense with Nationwide Rendition authorized.

**4. ANGELO M. ROSADO**, 53, classified as a Level 3 Sex Offender by the Massachusetts Sex Offender Registry Board, wanted for four counts of failure to register as a sex offender as

required by law. ROSADO was convicted in 1991 of rape of a child under 16 with force, assault and battery with a dangerous weapon, and robbery, stemming from an incident in which he and his co-defendant dragged a girl under a bridge in Boston, struck her with a large object, and took turns raping her. Following his completion of a state prison sentence ROSADO has repeatedly violated his sex offender registration requirements. He has previous convictions for failure to register and an extensive criminal history in Massachusetts, Pennsylvania, New York, and New Jersey. He is Hispanic, 5'5" tall, about 140 lbs., with brown hair and brown eyes. He has numerous tattoos all over his body, including several teardrops under his left eye and a visible tattoo on the right side of his neck. He has used the alias ANGEL ROSADO and is possibly homeless.

### West Nile Virus detected in latest mosquito sample at New Bedford Business Park

The Massachusetts Department of Public Health (MDPH) has notified the New Bedford Health Department of the finding of West Nile Virus in a primarily bird-biting mosquito sample obtained in the area of the New Bedford Business (Industrial) Park, located off of Phillips Road in the far north end of New Bedford. The mosquito is of the Culiseta melanura species and is mainly bird-biting.

The New Bedford Health Department and Bristol County Mosquito Control Program has completed its spraying of parks and events for the season. With cooler overnight temperatures, mosquito surveillance is less effective and the small numbers of mosquitoes trapped are not indicative of actual risk. While spraying is no longer an effective tool in reducing the threat under current temperature conditions, other precautionary measures remain effective.

Though populations are declining as we move away from mosquito season and into colder weather, it remains important to take precautions to prevent mosquito bites. Residents are urged to apply mosquito repellent and use clothing to reduce exposed skin.

The risk of mosquito-borne illness typically extends until an area has experienced a hard frost. A hard, or killing, frost is defined meteorologically as two consecutive hours of temperatures below 28 degrees Fahrenheit. This will occur at different times for different communities, and there may even be variation within communities based on local geography. Although mosquitoes are not killed until a hard frost occurs, they are extremely unlikely to be active when temperatures fall below 50 degrees in the evening.

Like EEE and West Nile, the New Bedford Health Department works closely with the Massachusetts Department of Public Health to track other emerging mosquito-borne diseases such as the Zika virus. While Zika-carrying mosquitoes have not been identified the New Bedford area, and the Massachusetts Department of Public Health reports that the likelihood of becoming infected with Zika virus from a mosquito bite in Massachusetts is very low, residents are urged to take the general precautionary measures to prevent mosquito bites. In addition, travelers to areas where the Zika virus has been detected in mosquitoes or humans should take extra precaution to avoid being bitten by mosquitoes during their trip. This includes both females and males who travel to areas where the

Zika virus is occurring. If you or your partner is planning on traveling, you should check the Centers for Disease Control and Prevention website for information about where Zika virus occurring:
