## **Alleged New Bedford Fentanyl Dealer/Illegal Gun User Held as a Danger in Superior Court**

A 47-year-old New Bedford man, who was arrested earlier this year for selling fentanyl and possessing illegal firearms while on probation for a prior drug distribution conviction, was detained as a dangerous person by Superior Court Judge Thomas McGuire last Friday.

Richard Campbell was the subject of a dangerousness hearing on July 2nd in Fall River Superior Court after being indicted in June on charges of Trafficking more than 10 grams of Fentanyl, possession of a Class B Drug, Unlawful Possession of a

Firearm, Unlawful Possession of Ammunition, and Armed Career Criminal with two prior convictions.

After taking the matter under advisement for several days, Judge McGuire made his dangerousness finding, meaning the defendant will be held without bail during the pendency of the case. The case is being prosecuted by Assistant District Attorney Jason Mohan.

During the dangerousness hearing, ADA Mohan told the court that New Bedford Police received information that the defendant was selling fentanyl out of his apartment at 314 Chancery Street. The police utilized a confidential informant who conducted a controlled purchase of fentanyl from the defendant within fourteen days of his eventual arrest. Based on the controlled buy and other factors, New Bedford Police obtained a search warrant for the defendant and his apartment. Pre-search warrant surveillance on the defendant demonstrated that he was actively dealing narcotics. The defendant was followed around New Bedford, North Dartmouth and into Providence, Rhode Island where the detectives observed the defendant engage in narcotic-related activities. The defendant was followed from Providence to New Bedford, where he was stopped by the police. When the defendant was searched, a quantity of fentanyl was found on his person. The defendant was brought back to his apartment where officers discovered a total of 36.9 grams of fentanyl (combined with the fentanyl on his person when he was stopped), three suboxone strips and a half gram of cocaine, along with packaging materials and scales. The police also discovered a .25 caliber Beretta semi-automatic firearm and a box with 50 loose rounds of .25 caliber ammunition.

All information contained in this release was stated in open court and are only allegations at this point. All defendants are considered innocent until proven guilty.

"I am very pleased Judge McGuire found this defendant to be a

danger to the community and held him without bail. In this case, he is accused of selling fentanyl and possessing a firearm. He clearly poses a danger to the community based on these factors,” District Attorney Thomas M. Quinn III said. “This is the type of case in which a defendant who is charged with trafficking in narcotics, with a prior record, should be detained without bail instead of imposing an arbitrary cash bail that the defendant may or may not post.”

## **Taunton Child Rapist/Abuser Sentenced to Lengthy State Prison Term**

A 32-year-old Taunton man who raped and assaulted his young relative on numerous occasions was sentenced to serve 15 to 17 years in state prison after being convicted at trial in Fall River Superior Court, Bristol County District Attorney Thomas M. Quinn III announced.

Deosdete Faria was convicted during a jury trial of rape-aggravated by age, assault and battery with a dangerous weapon on a child and indecent assault and battery on a person under 14.

The six-day long trial was prosecuted by Assistant District Attorney Jennifer Thompson.

On April 16, 2016 the 11-year-old victim ran away after being beaten by the defendant with a belt the night before. When she was found, the child had bruising all over her face, shoulder and back. The child disclosed that the defendant had been molesting her for around four years. The evidence at trial

showed the defendant penetrated her digitally and performed oral sex on her, and also touched her breasts with his hands and mouth.

During a sentencing hearing before Judge William Sullivan, ADA Thompson argued for a 20 to 25 year state prison term, with five years of probation. The defense, however, recommended a 10 year state prison term with no probation.

Judge Sullivan sentenced the defendant to serve 15 to 17 years in state prison, to be followed by five years of supervised probation.

"This defendant took advantage of his relationship with the victim by violently beating and molesting her. She was only a child and should have been enjoying life instead of being subjected to this type of despicable conduct. The sentence was well deserved.," District Attorney Quinn said.

The terms of his probation include:

a) The defendant shall attend sex offender treatment at his own expense as directed by the Probation Officer and as ordered by the court, at a program approved by the Probation Department, and shall remain in treatment unless and until professionally discharged by the approved sex offender therapist;

b) The Defendant shall provide the Probation Department with signed releases as to any therapy/treatment he attends throughout the term of Probation;

c) The defendant shall not reside in a household with minor children (including his own);

d) The defendant shall have no unsupervised contact with minor children.

e) The defendant shall have no supervised contact with minor children unless and until the supervisor has been approved in

advance by the Probation Officer and informed by Probation Officer of the offense for which the defendant is on probation and of any other sexual offense for which the defendant has been found guilty.

f) The defendant shall not be employed in a job that puts him into contact with minor children on a regular basis and all employment must be approved in advance by the Probation Officer.

g) The defendant shall not perform volunteer activities that put him into contact with children on a regular basis and all volunteer activities must be approved in advance by the Probation Officer.

h) The defendant shall not date any parent of a minor child without permission from the Probation Officer and, if permission is granted, said individual must be informed by the Probation Officer of the offense for which the defendant is on probation and of any other sexual offense for which the defendant has been found guilty.

i) The defendant shall comply with his legal obligations to register with the Sex Offender Registry Board.

j) The defendant shall be subject to GPS monitoring as required by statute for the entirety of his probation sentence with exclusion zones as to the victim when she is in Massachusetts, and agrees that the exclusion zones for GPS may be altered as deemed appropriate by probation. The exclusion zone suggested is Taunton, Massachusetts.

## **Fall River Armed Career Criminal Sentenced to State Prison**

A 23-year-old Fall River gang member was sentenced to serve four to five years in state prison after being convicted of illegal firearm charges and deemed an Armed Career Criminal by the court, Bristol County District Attorney Thomas M. Quinn III announced.

Mahamadou Kante was convicted after a three day trial in Fall River Superior Court of carrying an illegal firearm and possessing an illegal firearm with a defaced serial number. The defendant was then convicted of being a Level III Armed Career Criminal during a bench trial.

On February 26, 2017, members of the Fall River Police Street Crimes Unit witnessed the defendant operating a motor vehicle and recognize him as a violent gang member without a valid

driver's license.

Officers proceeded to a known hang-out where they saw defendant walking out of an alleyway. When the defendant saw the police officers, he crouched by the rear passenger wheel well of a parked vehicle. Officers searched and recovered a loaded .380 handgun with the serial number filed off placed on top of the tire.

Surveillance camera footage exhibited during trial shows the defendant crouching near the wheel well immediately before being arrested.

The case was prosecuted by Co-Forst Assistant District Attorney Karen O'Sullivan and Assistant District Attorney Zach Mercer.

During a sentencing hearing before Judge William Sullivan, prosecutors argued that the defendant's lengthy criminal record and his continued use of illegal firearms in the City of Fall River warranted a five to seven year state prison sentence. The defendant, however, requested a more lenient three year state prison term.

Judge Sullivan sentenced the defendant to serve four to five years in state prison, followed by three years of supervised probation.

"This case highlights the importance of surveillance video, which was a key to obtaining a conviction in this case. Surveillance shows the defendant crouching next to a tire where gun was located. He is a known gang member who previously assaulted an officer during a drug deal. The sentence will protect the citizens of Fall River from this violent defendant," District Attorney Quinn said.

# Traffic Stop Leads to Arrest and Kilo of Cocaine, \$27,000 in Lancaster

Last night, at approximately 9:10 p.m., Trooper Juan Sandoval was on I-190 southbound in Lancaster, traveling to a paid detail when he observed a 2017 Toyota Camry commit motor vehicle violations. When Trooper Sandoval signaled the vehicle to stop for the violation, just prior to Exit 6, the vehicle came to an abrupt stop in the left travel lane. After being instructed to pull to the right, into the breakdown lane and stopping, the driver, later identified as FELIX A. MARTINEZ-SANDEZ, 20, of Bronx, New York, pulled the vehicle into the right lane and continued driving for approximately one-quarter mile before finally stopping in the breakdown lane.

As a result of conversation, and subsequent investigation, MARTINEZ-SANDEZ was found to be in possession of a kilo of cocaine (1,000 grams) as well as over \$27,000 in U.S. currency believed to be direct proceeds of illegal narcotic distribution.

MARTINEZ-SANDEZ was placed under arrest and transported to the Leominster Barracks for booking.

FELIX A. MARTINEZ-SANDEZ was charged with the following:

1. Trafficking cocaine
2. Unlicensed operation of a motor vehicle
3. Fail to drive in the right lane
4. Obstruct emergency vehicle



MARTINEZ-SANDEZ was held on \$100,000 bail pending arraignment this morning in Clinton District Court.

# 32-year old Plymouth man killed in Route 90 crash in Grafton

Update: The victim from yesterday's fatal crash on Route 90 in Grafton has been identified as Joshua Glynn, 32 of Plymouth.

At approximately 2:22 p.m., troopers from the State Police Barracks in Charlton responded to reports of a crash on Route 90 Westbound at the 98.5 mile marker in Grafton, which resulted in the death of the operator.

Preliminary investigation by Trooper Thomas Wilson indicates that a 2015 Ford Fusion was traveling on Route 90 Westbound when for reasons still under investigation it went into the breakdown lane where it struck the rear of a disabled tractor-trailer which was parked in the breakdown lane.

The operator of the Ford was determined to be deceased at the scene due to injuries sustained in the crash. The operator of the tractor-trailer, a 45-year-old man from Miami, Fla. suffered no injury.

The right travel lane and the breakdown lane on Route 90 Westbound were shut down while the crash was investigated.

The cause of this crash remains under investigation.

Trooper Wilson is being assisted in this investigation by the State Police Collision Analysis and Reconstruction Section, the State Police Crime Scene Services Section, Commercial Vehicle Enforcement Section and Worcester County DA's Office. Also assisting on scene were members of Grafton Fire and EMS, the Medical Examiner's Office and MA Department of Transportation.

# Milford Woman Pleads Guilty to Stealing \$2.7 Million from Employer

A Milford woman pleaded guilty Tuesday in federal court in Boston to stealing approximately \$2.7 million from her employer and then using the money to purchase luxury items, many of which she resold to consignment shops.

Debra Mulloy, a/k/a Debra Depaul, 57, pleaded guilty to two counts of wire fraud and one count of aggravated identity theft. U.S. District Court Judge F. Dennis Saylor IV scheduled sentencing for Oct. 9, 2018.

From 2004 through 2016, Mulloy was responsible for most of the financial and organizational duties at the company for which she was employed. On multiple occasions from April 2012 to December 2016, Mulloy used the company's credit card account in the name of another employee to make hundreds of unauthorized charges totaling nearly \$2.4 million. Most of those unauthorized purchases were for clothing, furs, and jewelry at boutique stores in the Boston area. Mulloy then sold many of the luxury items at consignment shops. As part of her scheme, Mulloy also caused company checks to be issued for her personal benefit, primarily to pay her personal credit card bills. In total, Mulloy defrauded her employer of approximately \$2.7 million.

The charge of wire fraud provides for a sentence of no greater than 20 years in prison, three years of supervised release, a fine of \$250,000 or twice the gross gain or loss, whichever is greater, and restitution. The charge of aggravated identity

theft provides for a mandatory two-year sentence that must run consecutively to any other sentence imposed, one year of supervised release, a fine of \$250,000 or twice the gross gain or loss, whichever is greater, and restitution. Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and other statutory factors.

United States Attorney Andrew E. Lelling and Harold H. Shaw, Special Agent in Charge of the Federal Bureau of Investigation, Boston Field Division, made the announcement today. Assistant U.S. Attorney Mark J. Balthazard of Lelling's Economic Crimes Unit is prosecuting the case.

# **National Park Travelers Club 16th Annual Convention in New Bedford, July 19-21**

The National Park Travelers Club (NPTC), a diverse group of over 2,200 National Parks enthusiasts representing almost every state and multiple foreign countries, will hold its 16th annual convention from July 19th through 22nd, 2018, in New Bedford, Mass.

The Fairfield Inn New Bedford will serve as the host hotel while the New Bedford Whaling Museum will serve as the host venue for the Club's Annual Meeting on Saturday, July 21, 2018. Over the four days, the club will hold various group outings to the area National Parks including Cape Cod Nat'l. Seashore, Roger Williams Nat'l. Memorial, Blackstone River Valley Nat'l.

Historical Park's Slater Mill, Touro Synagogue Nat'l. Historic Site, as well as New Bedford Whaling Nat'l. Historical Park. They are anticipating nearly 175 members will be in attendance this year.

The NPTC was founded in 2004 to connect and provide fellowship to all those who enjoy visiting the currently 417 units managed by the National Park Service. Following the 2016 year-long Centennial Celebration of the National Park Service, interest in America's National Park System is higher than ever. cancellations in the Passport to Your National Parks® program. Passport books for this program are available for purchase in nearly all park visitor centers. The visitor centers provide rubber ink stamps that imprint the name of the park, the city and state of the Park's location, and the date of the visit.

This program was created in 1986 by Eastern National, Inc. (formerly the Eastern National Park and Monument Association).

The 2018 NPTC Convention will recognize eight members (Jim & Donna Bischoff, Glenn Fankhauser, David Kroese, Dave & Sue Lutz, Carl Raboi and Thomas Wright) with its highest honor, the Platinum Lifetime Achievement Award, given for visiting all 417 units of the National Park System. To date only 56 individuals are known to have ever achieved this challenging goal of visiting every National Park Service unit in the country; this includes not only the 60 National Parks but also National Monuments, National Historic Sites, National Battlefields, National Seashores, etc.

Convention speakers include Acting Superintendent Jennifer Smith and Park Ranger Mark Mello of New Bedford Whaling Nat'l. Historical Park as well Park Ranger Andrew Long who is assigned to the developing Coltsville Nat'l. Historic Site in Hartford, Conn.
