New Bedford High School Earns Coveted NEASC Accreditation

New Bedford High School has earned its reaccreditation in the New England Association of Schools and Colleges (NEASC). The reaccreditation process — a comprehensive examination and institutional self-study — began in March 2015 and included on-site evaluations by a 16-member team, classroom observations, student shadowing, facilities review, and indepth meetings with teachers, students, parents, and administrators.

In a letter to Headmaster Bernadette Coelho dated October 25, 2017, NEASC Director, George H. Edwards, and Associate Director, Kathleen A. Montagano, noted "The Committee was impressed with many of the programs and services and wishes to commend the following:

- the involvement of significant numbers of representatives in an inclusive process to identify and commit to a set of core values and beliefs about learning, resulting in significant internalization, especially by faculty, students and other stakeholders
- the school's creation and design of strong analytic rubrics which define targeted high levels of rigor and performance for the academic, civic, and social learning expectations
- the purposeful design of the curriculum which provides students with opportunities to practice and achieve the school's learning expectations
- the significant progress shown to date for writing a curriculum in a common format that is uploaded to the Atlas digital platform and provides teachers with an opportunity to collaborate on shared learning experiences for students

- the provision of ample dedicated time, personnel, and financial resources for teachers to collaborate in the review of the curriculum including emphasis on using results and current research
- the progress made to date in aligning instructional practices with the school's core values, beliefs, and 21st century learning expectations
- the introduction of evidence-based teaching and learning strategies to support students' achievement of the school's
 21st century learning expectations
- the progress in identifying lead learners to serve as instructional models and leaders for their peers to ensure consistency with the school's core values, beliefs, and 21st century learning expectations."

Superintendent Dr. Pia Durkin noted "NEASC Accreditation is a leading indicator that New Bedford High School makes the grade for its commitment to academic excellence, while providing students with a safe, positive, respectful, and supportive school culture. This endorsement validates the ongoing work of the entire staff while recognizing their professionalism and dedication. Awarded by the foremost independent review body in K-12 education, this important credential should reinforce the public's confidence in their high school as well as affirm New Bedford High School as the school of choice."

Headmaster Bernadette Coelho said "We thank NEASC for guiding us through a vigorous and thorough examination of all aspects of school operations and the delivery of a quality education that equips our students for higher learning and work in the 21st century. We integrate the NEASC standards in all that we do at New Bedford High; fostering student responsibility for learning and results with high expectations for all."

"NEASC accreditation is an important, third-party validation of New Bedford High School's rapid progress," said Mayor Jon

Mitchell. "I commend the school's staff and students, as well as the administration, for all of their hard work throughout the process."

As stated on the NEASC website "Accreditation is an expression of confidence in the institution's purposes, performances, human and financial resources" and "attests to substantial compliance with established qualitative standards, integrity in statements to the public describing the institution's program, institutional commitment to improvement, and sufficiency of institutional resources. The goals are effectiveness, improvement and public assurance."

Accreditation requires ongoing reporting to NEASC, including substantive two-year and five-year reports in a structured ten-year cycle of examination and peer-review.

NEASC institutional literature notes "Membership in and accreditation by the NEASC is similar to membership in professional organizations such as the American Bar Association and the American Medical Association. In each case, a commitment toward continual self-evaluation, a pledge to self-improvement, and a desire to maintain the Standards for Accreditation are necessary."

Captain with Bristol County Sheriff's Office Indicted for Smuggling Profits to Portugal

A Captain with the Bristol County Sheriff's Office was indicted yesterday by a federal grand jury in connection with helping Carlos Rafael, the owner of one of the largest

commercial fishing businesses in the U.S., smuggle the profits of his illegal overfishing scheme to Portugal.

Jamie Melo, 45, of North Dartmouth, Mass., was indicted on one count each of bulk cash smuggling, structuring and conspiracy. In August 2017, Melo was arrested and charged in a criminal complaint.

In May 2015, federal agents began an undercover operation targeting Carlos Rafael, the owner of one of the largest commercial fishing businesses in the U.S. In the fall of 2015, undercover agents, posing as potential buyers of Rafael's business, met with Rafael to negotiate buying his fishing business. Rafael told the agents that he hid the cash proceeds of his illegal fishing sales, in part, by smuggling the money to Portugal. As alleged in court documents, Rafael said that he sometimes took the money himself, but also used the services of others, and referred to knowing several members of the Bristol County Sheriff's Office, including Melo, whom he described as, "the captain at the prison."

As alleged, on Nov. 10, 2015, agents conducting surveillance at Logan Airport saw Melo and Rafael arrive in a van, marked as belonging to the Bristol County Sheriff's Office, for a flight to Portugal. Melo completed TSA screening without incident, but Rafael was found in possession of \$26,400, for which he completed a federal reporting form. Several other acquaintances of Rafael and Melo were also on the flight and, allegedly coordinated by Melo, helped Rafael smuggle an additional \$50,000 in cash to Portugal. It is further alleged that before the flight, Melo distributed envelopes of cash to these acquaintances, each of whom took an envelope on the flight and returned it to Melo or Rafael after landing in Portugal. Two days later, on Nov. 13, 2015, Portuguese bank records indicate that Carlos Rafael deposited \$76,000 in U.S. currency into a Banif Bank account.

The charge of conspiracy provides for a sentence of no greater than five years in prison, three years of supervised release and a fine of \$250,000. The charge of bulk cash smuggling provides for a sentence of no greater than five years in prison, three years of supervised release and a fine of \$250,000. The charge of structuring carries a sentence of no greater than 10 years in prison, three years of supervised release, and a fine of \$500,000. Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and other statutory factors.

Three City Councilors call attention to living conditions at King Village Apartments

Three New Bedford City Councilors have filed a late motion to spotlight the living conditions at King Village Apartments. The following will be addressed tonight at the New Bedford City Council session:

WRITTEN MOTION, Councillors Carney, Gomes and Dunn, requesting, that Congressman Keating, State Senator Montigny, Representative Cabral, a Representative from the Department of Housing and Urban Development (HUD) and the Department of Housing and Community Development, walk through the King Village Apartments to immediately address the deplorable conditions that residents are forced to live in since the new ownership has taken over; and further, that the Committee on Appointments and Briefings meet with King Village Ownership

and HUD Officials to discuss the environmental concerns, security measures, maintenance and building construction.

New Bedford unveils two new fire engines

New Bedford Mayor Jon Mitchell, Fire Chief Michael Gomes, and City officials unveiled the New Bedford Fire Department's two new fire engines, and stressed the importance of modernizing the City's fleet of public safety vehicles at a press conference this morning.

"One of my priorities as Mayor has been to make City services more effective," said Mayor Mitchell. "With the guidance of our CFO, Ari Sky, we have modernized City government and provided public safety professionals with the equipment necessary to protect our residents."

The two new engines are 2017 Pierce Arrow XT 1,500 gallons-per-minute pumpers, with significant more capacity than the pumpers they replace. The new apparatuses are technologically advanced and corrosion-resistant.

Engine 5 will be stationed at Fire Station 5, 3665 Acushnet Avenue. Engine 9 will be stationed at Fire Station 9, 799 Ashley Boulevard. They replace two engines which began service in 1994 and 2002.

In 2012, when Mayor Mitchell first took office, the average age of the full NBFD fleet was 14 years old, and is now an average of 8.5 years old. With the acquisition of these new fire engines, the City has now replaced 5 vehicles in its frontline fire fleet of 10 vehicles in the past 4 years.

"These new engines will improve our response capabilities and are a wise investment as the City continues to prioritize public safety vehicles for the benefit of all New Bedford residents," said Chief Gomes.

"The apparatus replacement program has allowed us to significantly improve the condition of our front-line fleet in a relatively short timeframe," said Ari Sky, the City's Chief Financial Officer. "This type of long-term planning is an essential factor in our efforts to address the deferred capital needs that have accumulated over the course of several decades, and has resulted in a sustainable debt profile which is affordable in terms of the annual budget."

Police, Fire, Emergency Medical Services equipment and vehicles have been identified as top funding priorities for the City of New Bedford in the biennial Capital Needs Assessment in the Capital Improvement Plan (CIP). The CIP is the City's first long-term plan developed to address the facilities and equipment needs of city government.

Mayor Mitchell directed CFO Sky to develop the Plan, which was first introduced in the fall of 2013 and has been updated annually. The plan was designed to ensure that the highest priority projects, like public safety vehicles, receive public funding in a manner that is in keeping with the City's ability to pay.
