## **Wanted fugitive crashes stolen car, loses arm near Route 18 in New Bedford**

New Bedford Police are investigating a late night crash involving a stolen motor vehicle from the town of Fairhaven. On Thursday evening at approximately 10:30PM, Detectives spotted a Honda Civic operating the wrong way on Acushnet Avenue near Beetle Street. As detectives attempted to pull over the vehicle it sped off and eventually got onto Rte 18 south bound. As Detectives got onto Rte 18 they later discovered the vehicle had crashed at the Purchase Street exit.

The vehicle rolled over upon impact of the guard rail and the single male operator was partially ejected from the vehicle. The male operator sustained serious injuries including his left arm being severed at the elbow and was transported to Rhode Island Hospital where he is listed in serious condition.

The vehicle he was operating was stolen near Paul's Sports Corner in Fairhaven shortly before being spotted by

Detectives. The male operator had no identification on him and his identity was unknown until this morning when New Bedford Police Detectives were able to fingerprint him and submit the prints to the Mass State Police in Lakeville where his prints were put through the AFIS system and identified. He has been identified as a 56 year old male from Dorchester. His identity is being held pending notification to next of kin.

This male has an extensive record in Massachusetts, New York, South Carolina, Georgia and Florida. It has been learned that there is a full extradition warrant from Atlanta Georgia for parole violations and also an outstanding warrant from Brookline Mass district court for him. The New Bedford Police Department's accident reconstruction team is also assisting in the investigation. He will be facing several charges.

## **New Bedford Police narcotics and gang units make 14 arrests in Wednesday sweep**

New Bedford Police narcotics and gang units made 14 arrests Wednesday and took a gun and narcotics off the street as part of a citywide sweep targeting narcotics use and other illegal activity.

As part of the sweep, police executed a search warrant at 311 Coggeshall St. Apt. 1 as part of an investigation into a cocaine distribution service out of that address.

Police seized a loaded 9mm Taurus Slim semi-automatic pistol and an additional magazine containing 9mm ammunition. A small amount of crack cocaine, digital scales and packaging materials were also located along with a small amount of cash.

"There are so many amazing and diverse restaurants within our reach," says Ryan Caton, founder of GotChew along with William Gilmour and Justin Baker. "Seeing other major cities with these types of services but not having it at home, really pushed us to make it happen."



The process is simple – like, amazingly simple. Don't have to make a phone call, or browse a bunch of websites, or even leave your couch if you don't want to.

From the nifty GotChew phone app (free to download onto your smartphone) or website, just pick a restaurant, choose what you want off the menu, pay with your credit card or debit card and ... well, and nothing. Just wait for the food to arrive, hot and fresh, from your friendly delivery driver, and it's restaurant time in your living room. Optionally, you can contact us after you order something to go and we'll pick up it and deliver it to you.

Even better, if you create an account and input your information once, it's locked in (and secure), ready to go whenever you are.

GotChew has been open for four months and any early kinks have been ironed out thanks to hard work and the energy from happy customers (4.9 out of 5 rating on Facebook from 50+ reviewers).

“A few weeks back we had our first elderly customer,” Ryan Caton recalls. “She had no form of transportation, but she heard about us and decided to use our service – we were able to bring her a cacoila sandwich, which is her favorite! That was really cool.

“Numerous times we have delivered to people who are smiling ear to ear and tell us how much they love what we are doing and how much they enjoy our service,” he says. “This is very gratifying for us and pushes us to want to continue to keep improving.”



They currently deliver for nine different restaurants, including downtown favorites like Freestone’s, Greasy Luck and DNB Burgers, along with good-old-reliable Subway. They project to represent 20 restaurants by the end of the year, and are meeting with new local restaurant owners every day to help convert them to the delivery revolution.

The GotChew idea went from dream to reality thanks in large

part to the support and inspiration from the EforAll business incubator program in New Bedford.

“It’s an amazing program,” Caton says. “They can help turn an idea into a tangible business. You’re given mentors that help you with the building process and are there for insight and advice along the way.

“We couldn’t have done it without them – if you have an idea or a product in mind, nothing gets accomplished by just thinking about it. Sometimes the best way to learn is by doing.”

In addition to the concept, one of GotChew’s unique attributes is its soon-to-be-iconic logo, featuring green script reminiscent of alternative comics with a happy, hungry mouth making the “C” of the Chew.

“We’ve had a lot of fun with that,” says Caton, noting that Gilmour is the designer and media mogul, and creating the right logo was of high importance. Working off a sketch by Gilmour and working it into shape with help from Just Your Way Screen Printing of Westport, they came up with something memorable.



“At first it was a little delivery car with catering tray,” Gilmour said. “Then it was like ‘Let’s use the name,’ and I started sketching it up. First it looked like a face, then we got rid of the eyeballs and the nose, and focused on that mouth, ready to eat. At first, we were like, ‘I don’t know,’ but as it got better and better we really fell in love with it.”

“People love the logo, we’ve gotten a lot of feedback, it’s kind of warm and inviting.”

And, Caton emphasizes, GotChew expects that logo to become more and more well-known with every month that passes.

“We want it to be everywhere,” he says. Magnets on the cars, all over social media, we are really working to make this happen for the people of New Bedford.”

In addition, GotChew is excited to create jobs in the city.

“Creating the opportunity for a flexible, secondary form of income for people in the city is a major benefit,” says Baker, the team’s technical guru. “This service brings in an entire new type of employment to the city, allowing drivers to be able to choose their own schedule that works for them.”



# Seekonk Home Invasion Defendant Sentenced to State Prison

A 24-year-old Attleboro man who broke into a Seekonk home last August and assaulted the homeowner was sentenced to serve four to five years in state prison last week, Bristol County District Attorney Thomas M. Quinn III announced.

David Allard pleaded guilty in Fall River Superior Court to a five-count indictment charging him with breaking and entering during the daytime-person in fear, armed robbery, assault and battery, larceny over \$250, and armed assault in a dwelling.

On Tuesday, August 16, 2016 at approximately 3pm, Seekonk Police received a frantic 911 call from a homeowner on Apple Orchard Lane. The homeowners, both in their mid-60's, came home to an intruder. The victims noted a door open in the sunroom, which is always closed. The male victim went upstairs to the bedroom area to investigate. While walking up the stairs, the male victim confronted the intruder on the stairs between the two floors. The defendant grabbed the male victim by the throat and pushed him out of the way. The struggle resulted in an injury to the male victim's neck area.

The female victim was on the first floor. As the defendant tried to pass her while carrying a green bag (which contained their personal items), she attempted to grab for it. The defendant yelled, "I'll stab you", while reaching toward his pocket area. She was petrified and yelled for her husband to let the defendant out of the house.

While the female victim called 911, the male victim followed the defendant down the street as he fled with a bag of stolen property. Police arrived within moments and saw the defendant with the green bag and confronted him, at which point he fled

on foot into the woods. After setting up a perimeter of the surrounding area, the defendant was located and placed under arrest. Recovered was the green bag with the victims' personal property, including, among other things, \$300 cash, a watch, and assorted jewelry. A screwdriver was also recovered. The defendant was also carrying a knife with a 4 ½ inch blade.

Both victims addressed the court during the defendant's sentencing hearing last week, telling Judge Raffi Yessayan that the defendant's actions have made them both fearful in their own home in the year since the incident occurred. "The entire incident goes beyond upsetting. It is life altering. Our family will never feel the same in our own home," the male victim told the judge. His wife concurred, telling Judge Yessayan, "I was innocent enough to believe that when I locked my windows and doors at night, I was safe. That security was all taken away in one afternoon. At night, I sat up in our family room, because I could not bear to go upstairs to bed. I was also afraid to come home to an empty house."

During the sentencing hearing, Assistant District Attorney Jeanne Veenstra argued for four to eight year state prison term, with an additional probationary period upon the defendant's release from prison. Judge Yessayan sentenced the defendant to serve four to five years in state prison, to be followed by three years of supervised probation.

"The violent assault on the homeowner while trying to flee is simply unacceptable," District Attorney Quinn said. "People have a right to the quiet enjoyment of their home and should never have to be subjected to thefts and assaults from thieves inside their own home."

# **Amber Alert suspect being charged with attempted murder**

LEEANN RICKHEIT, 38, the suspect arrested in last night's AMBER Alert, is expected to be arraigned this morning in Dudley District Court on several charges, including attempted murder.

When state troopers from the MSP's Violent Fugitive Apprehension Section located RICKHEIT's car in the woods early this morning, RICKHEIT and her daughter were in the car, the car was running, and the tailpipe had been stuffed with clothing, blocking the exhaust. Troopers observed the mother and daughter Ella either sleeping or unconscious in the car.

VFAS Trooper Keller Williams smashed a window to the vehicle and troopers removed the child and RICKHEIT from the car. Two

ambulances were called to the scene and Ella was transported to UMASS Medical Center and Rickheit to St. Vincent's in Worcester.

The child is reported to be doing well and RICKHEIT, who was kept under police guard, was held at the State Police Barracks in Sturbridge and will be arraigned today on charges of attempted murder, assault and battery on a child, and reckless endangerment of a child.

The location where VFAS Troopers found the suspect and victim in the car was on the backside of a pond located through the woods behind the Country Store, 131 Stafford Street, Charlton.

VFAS Troopers learned that RICKHEIT frequented that area and often slept in her car there. The troopers had focused on the area after intelligence that was developed led them to check various addresses in Sturbridge and Charlton for RICKHEIT. The troopers conducted numerous interviews of people who might have information about her whereabouts.

VFAS Troopers who worked the case throughout the night were Sgt David Skelly and Troopers Keller, Amy Waterman, and Thiago Miranda. They were assisted during the recovery and arrest by troopers from the Sturbridge Barracks and Charlton Police. Troopers from the State Police Detective Unit for Worcester County assisted in the followup investigation.
