New Bedford Snow Emergency Parking Ban Effective 7AM Friday

The National Weather Service in Taunton has issued a Winter Storm Warning for heavy snow, which is in effect from 3AM to 4PM Friday, March 10, 2017. According to the National Weather Service, snow is expected to overspread the region early on Friday morning and last through much of the day before ending mid afternoon. At this time, the forecast for the New Bedford area calls for a likely 6 inches of snow with the potential for as much as 10 inches.

Citywide Snow Emergency Parking Ban Effective 7AM Friday, March 10, 2017

In preparation for the approaching snowstorm, the City of New Bedford has announced a citywide snow emergency parking ban to take effect at 7AM tomorrow, Friday, March 10, 2017. The parking ban will be strictly enforced and will remain in effect for 48-hours thereafter, unless lifted or further extended by City officials. The parking ban is designed to allow City workers to efficiently remove snow from New Bedford roadways to permit public safety vehicles and residents to travel safely.

While the snow emergency parking ban is in effect, parking is permitted on the north side of all streets going east and west, and is permitted on the east side of all streets going north and south. The permitted side of the street is typically the side opposite of the fire hydrants.

Please note that on streets which are normally posted for parking on one side of the street only, residents are to obey the signs as usual.

Vehicles should never be parked within ten (10) feet of a fire

hydrant or twenty (20) feet from a corner as required by law, regardless of whether a snow ban is in effect, or not.

Double-sided Parking Ban Areas

To increase public safety during storm events, areas designated for a double-sided parking ban have been expanded to now include sections of five new streets (listed below), in addition to the Downtown and Acushnet Avenue Business Districts where a double-sided ban had been in place in years past. These changes began last winter.


The new street sections were selected because they are major routes for ambulances, school buses, and SRTA buses, and have a history of large vehicles being unable to successfully navigate due to the narrowness of the street.

During a snow emergency parking ban, no parking is therefore permitted on either side of the street in the following areas:

- Downtown Business District: Downtown New Bedford between Walnut Street northerly to the Octopus and County Street easterly to JFK Boulevard
- Acushnet Avenue Business District: Acushnet Avenue,
 Coggeshall Street to Tarkiln Hill Road
- Ashley Boulevard (from Nash Road to Coggeshall Street)
- County Street (from Union Street to Sawyer Street)
- Kempton Street (from Rockdale Avenue to Pleasant Street)
- Mill Street (from Rockdale Avenue to Pleasant Street)
- Cottage Street (Union Street to Durfee Street)

Violations of the snow emergency parking ban will be subject to ticketing at \$50 per ticket and towing at full cost to the owner of the vehicle towed. The vehicle owner is also responsible for the full cost of storage for any towed vehicle.

The National Weather Service in Taunton has issued a Winter Storm Warning for heavy snow, which is in effect from 3 AM to 4 PM EST Friday. The Winter Storm Watch is no longer in effect.

- * LOCATIONS...Rhode Island and Southeast Massachusetts. This includes the cities and towns of Taunton, Brockton, Plymouth, Fall River, New Bedford, Mattapoisett, Foster, Smithfield, Providence, Coventry, West Greenwich, East Greenwich, Warwick, West Warwick, Bristol, Narragansett, Westerly, and Newport.
- * HAZARD TYPES...Heavy snow.
- * ACCUMULATIONS...Snow accumulation of 4 to 8 inches. There will be a sharp cutoff to the snowfall from south to north over a very short distance. In addition the storm`s snow bands will be very narrow resulting in a fairly large snowfall range.
- * TIMING...Snow will develop after midnight, becoming heavy at

times during the morning and into midday Friday. The snow will taper off around mid afternoon Friday.

* IMPACTS...The heavy snow will make many roads impassable especially with snowfall rates of 1 to 2 inches an hour at times.

The 10-barrel, Moby Dick Brewing Com. is the first hometown brewery in 40 years and offers a full-service bar featuring their very own beers and ales intelligently paired with with a pub fare menu.

Don't think "pub" though, this is a classier affair: the Moby Dick Brewing Co. has a friendly, family setting that seats 100. It expects to serve guests in outdoor seating along Union Street on the cobblestone sidewalk that was installed by the city to help attract investors to the downtown historic district. They brewery will features special events and offer tours.



While this is certainly something to get excited about, what makes Moby Dick Brewing Co. special, as in any venture, is the people behind the project.

The company's president and the one who will be leading operations is David Slutz, formerly CEO of Precix. He's now managing director of investment firm, Potentia Business Solutions. He had this to say about the concept: "The brewpub's design, menu and atmosphere will echo New Bedford's historic whaling and fishing history with authentic artwork, photography and artifacts."

General Manager Tim Cleland's entire professional life has been spent within the restaurant and hospitality industries, including 10 years with Rock Bottom Breweries in Chicago and Boston. He's won numerous industry awards over his career.

Passionate, inspired, head chef, Tom Mackley has also spent his professional career as chef of restaurants on the West (including the the famous "Lola" in Seattle) and East Coasts, and at restaurants whose maxims are using the freshest *local* ingredients, and crafting menus that pair with superior beers and ales.



While many of the menu items have been placed on the menu so as to compliment the brewery's ales and beers, there's quite a variety of other dishes. Many standards are on the menu, like a simple green salad, fish and chips, grilled cheese, grilled pork loin, pan seared scallops, chicken wings, burgers. etc. There are some rather uncommon or rare selections.

The Marinated Beet Salad has whipped ricotta, arugula, shallots, aged Sherry vinegar and pistachios. There's a Sweet Potato and Apple Soup with Harissa spice, corn nuts and mint. Cornmeal Fried Oysters — six, plump Virginica oysters deep fried and served with green garlic Ranch dressing. Beer Steamed Mussels or Littlenecks with linguiça, spring onion, olive oil, served with fries. Beer Brined Chicken Breast with Granny Smith apples and pale ale mustard. Pan roasted Skate filet, fresh Cavatelli pasta, grilled mushrooms and grits, salt cod chowder, Carolina Gold seafood rice, and more round out the menu, which you can see in all its glory here

But, beer. Some of you came to find out about the beer. What is the beer being served at the brewery like? What inspires the brewmaster? Brewing for most of his adult life, awardwinning brewmaster Scott Brunelle describes what he likes: "...ales that are perfectly balanced, Pilsners that sparkle, American lagers that taste crisp and clean, stouts that are rich and complex. I prefer IPAs, but appreciate all the traditional beer types so long as they're done correctly. I'm a sucker for tradition so I like a lot of the classic styles."

Man assaults two MA State Troopers after traffic stop

Winter storm watch in effect from late Thursday night through Friday afternoon

The National Weather Service in Taunton has issued a winter storm watch, which is in effect from late Thursday night through Friday afternoon.

Locations: south coast of Massachusetts from Westport to Cape Cod including the islands. This includes the cities and towns of Fall River and New Bedford.

Hazard types: snow.

Accumulations: snow accumulation of 4 to 7 inches possible,

Timing: snow overspreads the area Thursday night from west to east and continues into Friday before tapering off later in the day.

Impacts: snow, possibly moderate to heavy at times will impact the friday morning commute across the watch area.

Uncertainty: this storm will be accompanied by a narrow swath of accumulating snow. Therefore a shift in storm track as little as 50 miles will have a large impact on snowfall totals. Thus the watch highlights the potential for 4-7 inches of snowfall. Stay tuned to later forecasts and discussions for possible changes to our snowfall predictions.

Precautionary/preparedness actions

A winter storm watch means there is a potential for significant snow, sleet, or ice accumulations that may impact travel. Continue to monitor the latest forecasts. Be prepared to modify travel plans should winter weather develop.
