## Dominican National pleads guilty to unlawful re-entry following alleged involvement in Massachusetts overdose death

A Dominican national pleaded guilty today to unlawful re-entry of a deported alien. After reentering the United States within months of being removed, the defendant was charged with a heroin-related offense and was in possession of a phone that had been used in a drug transaction with an individual who died of an apparent overdose.

Joel Perez Matos, 35, who resided in Boston, pleaded guilty to unlawfully re-entering the United States after being deported. Perez Matos will be sentenced by U.S. District Court Judge Indira Talwani on Nov. 19, 2020. He has been detained since his arrest in April 2020 and will be subject to deportation following his sentence.

Perez Matos unlawfully re-entered the United States after being deported in December 2019. He had previously been removed in February 2016, and had unlawfully returned to the United States later that year.

On March 22, 2020, within a few months of having been removed from the United States, Perez Matos was arrested by local law enforcement in Stow and charged with a heroin-related offense. At the time of his arrest, Perez Matos was in possession of a cell phone that had been used the previous day to set up a drug transaction with a Massachusetts resident. On March 22, 2020, that resident died of an apparent drug overdose. When arrested, Perez Matos presented police with an out-of-state driver's license in a fake name.

Perez Matos faces a sentence of up to 20 years in prison, up to three years of supervised release and a fine of up to \$250,000. Sentences are imposed by a federal district court judge based on the United States Sentencing Guidelines and other statutory factors.

United States Attorney Andrew E. Lelling and Todd Lyons, Field Office Director, Enforcement and Removal Operations, U.S. Immigration and Customs Enforcement, Boston, made the announcement today. The Stow Police Department also provided valuable assistance. Assistant U.S. Attorney Bill Abely, Deputy Chief of Lelling's Major Crimes Unit, is prosecuting the case.

Construction to take place during regular working hours (Monday – Friday), police details and traffic controls will be in place.

## UPDATE: Victim in Tuesday night Fairhaven Police cruiser versus pedestrian crash identified

The victim involved of the pedestrian/motor vehicle crash involving a Fairhaven Police cruiser on Tuesday night can now be publicly identified since his next of kin has been located and notified. The victim is 32-year-old Christian Lapaz-Dejesus. It appears the victim had recently been living in New Bedford. He remains in critical condition at Brigham and Women's Hospital in Boston.

Massachusetts State Police are currently investigating the incident.

At around 11 p.m. Tuesday, a Fairhaven Police cruiser was being driven westbound on Route 6 when it struck a pedestrian in the roadway just west of the 7-Eleven convenience store.

Lapaz-Dejesus was rendered aid by the officer driving the cruiser, and was then rushed to St. Luke's Hospital in New Bedford after sustaining serious injuries. He was later transferred to the hospital in Boston.

The police cruiser involved in the crash was a 2014 Ford Explorer.

The investigation into this crash is being conducted by Massachusetts State Police detectives assigned to the district attorney's office and accident reconstruction is being conducted by the Massachusetts State Police Collision Analysis and Reconstruction Section.

#### New Bedford's Community Preservation Act FY 2021 application round begins with

# virtual workshop

The New Bedford Community Preservation Committee (CPC) announces the launch of the FY 2021 Community Preservation Act (CPA) application cycle at an Application Technical Workshop, hosted by the Community Preservation Committee (CPC). The public is invited to attend this informational session on Thursday, September 3, 2020 at 6 p.m. via Zoom.

The CPC anticipates a budget of approximately \$1.9 million to fund CPA-eligible projects in FY21 and strongly encourages all those interested in applying for funding during this cycle attend the workshop to learn about the application process.

The Community Preservation Act was adopted by New Bedford voters through a ballot question in November 2014. This statewide enabling legislation allows communities to create dedicated funding for Open Space, Outdoor Recreational Facilities, Historic Preservation, and Community Housing activities in the city. Oversight is provided by the Community Preservation Committee, the body established by the City to manage the CPA program in New Bedford.

To date, New Bedford's CPA has funded 45 projects across the city, totaling over \$5.2 million dollars distributed to open space, recreation, historic preservation, and community housing projects. Projects funded include the exterior restoration of the Sgt. William Carney House by the Martha Briggs Educational Club, the acquisition of open space at the Acushnet Sawmill by Buzzards Bay Coalition, and the creation of the Sgt. Sean Gannon Memorial Playground at the Elwyn Campbell Elementary School. Additionally, this CPA funding has leveraged just over \$1.2 million dollars in private, state, and federal funding.

# Massachusetts State Police investigating alleged child sexual assault by former Boston Police officer

"The State Police Detective Unit for Suffolk County is conducting the investigation into PATRICK ROSE Sr., a former Boston Police officer accused of child rape and sexual assault who was first arraigned on crimes involving one victim two weeks ago.

Yesterday, ROSE, was arraigned on 16 additional charges alleging he repeatedly sexually assaulted and abused four

additional children, bringing the total number of his victims to five, according to Suffolk County District Attorney Rachael Rollins. The new charges include 11 counts of rape of a child (not aggravated) and five counts of indecent assault and battery on a child under age 14.

For three of the new victims, the rapes occurred in the 1990s, and for one of the new victims the indecent assault and battery occurred within the past two years.

The investigation into ROSE is ongoing. Anyone with additional information is asked to contact the Suffolk County State Police Detective Unit at (617) 727-8817."

# Massachusetts State Police utilize increased patrols during national "Driver Sober or Get Pulled Over" traffic safety campaign

"The Massachusetts State Police rolled extra patrols this past weekend as part of the national "Driver Sober or Get Pulled Over" traffic safety campaign.

The patrols were coordinated within each Troop through the Department's Traffic Programs Section. From Friday night through Monday morning, Troopers made 38 arrests for operating under the influence.

One driver who was stopped was charged with both OUI-alcohol

and OUI-drugs. Three of the OUI arrests were for drunk driving-second offense. One of those three blew a .18% on the breath test (legal limit is .08%); the other two refused the breath test, triggering automatic license suspension to go along with their upcoming criminal prosecution.

The highest breath test result was .24%, three times the legal limit.

The MSP will continue its increased presence through the Drive Sober campaign in the coming weeks."

# COVID-19 Update: FDA authorizes first diagnostic test where results can be read directly from testing card

Today, the U.S. Food and Drug Administration issued an emergency use authorization for the first antigen test where results can be read directly from the testing card, a similar design to some pregnancy tests. This simple design is fast and efficient for healthcare providers and patients and does not need the use of an analyzer.

"This new COVID-19 antigen test is an important addition to available tests because the results can be read in minutes, right off the testing card. This means people will know if they have the virus in almost real-time. Due to its simpler design and the large number of tests the company anticipates making in the coming months, this new antigen test is an important advancement in our fight against the pandemic," said Jeff Shuren, M.D., J.D., director of the FDA's Center for Devices and Radiological Health.

#### HOW IT WORKS:

A healthcare provider swabs the patient's nose and twirls that sample on a test card with a testing reagent added. After waiting 15 minutes, the healthcare provider reads the results directly from the testing card. One line indicates a negative result; two lines indicate a positive result.

#### WHERE IT CAN BE USED:

This test could be used at point-of-care settings, like a doctor's office, emergency room or some schools. This test has been authorized for use in patients suspected of COVID-19 by their healthcare provider within seven days of symptom onset. Given the simple nature of this test, it is likely that these tests could be made broadly available. According to the test manufacturer, Abbott, it plans to make up to 50 million tests available monthly in the U.S. at the beginning of October 2020.

#### **TEST DETAILS:**

In general, antigen tests are very specific, but are not as sensitive as molecular tests. Due to the potential for decreased sensitivity compared to molecular assays, negative results from an antigen test may need to be confirmed with a molecular test prior to making treatment decisions. Negative results from an antigen test should be considered in the context of clinical observations, patient history and epidemiological information.

The emergency use authorization was issued to Abbott Diagnostics Scarborough, Inc for its BinaxNOW COVID-19 Ag Card.

The FDA, an agency within the U.S. Department of Health and Human Services, protects the public health by assuring the safety, effectiveness, and security of human and veterinary drugs, vaccines and other biological products for human use, and medical devices. The agency also is responsible for the safety and security of our nation's food supply, cosmetics, dietary supplements, products that give off electronic radiation, and for regulating tobacco products.

### Jake Auchincloss joins South Coast endorsers for conversations on inclusive and equitable economic recovery
