

# Massachusetts State Police Add Two to Most Wanted List

The Massachusetts State Police today added two men wanted for attempted killings to the Department's list of Most Wanted fugitives. The suspects were added to the list by the MSP's Violent Fugitive Apprehension Section, which is leading the investigations, along with our local police partners, to track them down.

The first, JESSE G. OUELLET, 37, is wanted for two counts of armed assault with intent to murder, as well as for firearm offenses. The charges stem from evidence that OUELLET shot a man in the stomach outside the S&A Market convenience store on Ward Street in Worcester following an altercation on April 16, 2019. A bystander walking on the street was struck by a stray bullet. Both victims survived.

After the shooting OUELLET fled and Worcester Police obtained an arrest warrant.

He is white, approximately 5'5" and 150 lbs., with brown hair and brown eyes. He has many tattoos, including on both arms and his shoulders, stomach, and legs.

OUELLET should be considered armed and dangerous.

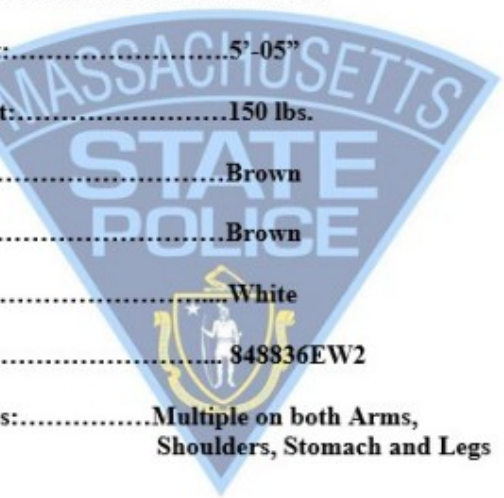

On April 16, 2019, at approximately 7:41PM, the Worcester Police Department responded to a shooting on Ward Street. Upon arrival, a male in obvious distress was located suffering from a gunshot wound to the stomach. The victim was transported to a nearby hospital with serious injuries and survived. An extensive investigation by the Worcester Police Department revealed that Jesse OUELLET was involved in a physical altercation with another male inside a convenience store. The altercation proceeded outside where OUELLET allegedly produced a firearm and fired two rounds at the male. An individual uninvolved in the incident was walking towards the store on Ward Street and was struck by a stray bullet. OUELLET fled and a warrant issued out of Worcester District Court for charges to include Armed Assault to Murder (2 cts), Carry Loaded Firearm, Discharge Firearm Within 500' of Dwelling, Possession of Ammunition and related. The firearm has not been recovered and OUELLET should be considered Armed and Dangerous. OUELLET has ties to the greater Worcester area and multiple tattoos on both arms, shoulders, stomach and legs. Massachusetts warrant #1962CR002428 and warrant #1962CR002432 exist for the arrest of OUELLET with Continental U.S. Extradition authorized.

The second fugitive added to the MSP's Most Wanted list is SAEED Y. ALI, 40, wanted for attempted murder, aggravated assault and battery, and vehicular offenses for running down his victim with a motor vehicle.

Evidence indicates that on July 12, 2019, ALI was driving a vehicle when, without warning, he intentionally struck a male relative of his former girlfriend as the man walked through a parking lot outside a Savers store on Memorial Avenue in West Springfield. After the initial impact ALI then backed over the

victim and then went forward again and struck him a third time.

The victim sustained extremely serious injuries including multiple bone fractures, severe lacerations, and broken teeth.

West Springfield Police obtained an arrest warrant for ALI. ALI has a lengthy criminal history including prior convictions for various assaults.

ALI is black, approximately 6' and 160 lbs., with black hair and brown eyes. He has multiple tattoos on his back and right shoulder, including a large dragon (ALI's wanted poster and a tattoo photo included with this release. He has connections to the Greater Springfield area.

On July 12, 2019, Sayeed Y. ALI reportedly encountered a family member of his ex-girlfriend at a store in West Springfield. As the family member later exited the store and walked through the parking lot, a motor vehicle allegedly driven by ALI intentionally struck him without warning. The vehicle then backed over the victim before continuing forward and striking him a third time. A parked vehicle was also struck during the incident and the victim was hospitalized with serious injuries to include multiple broken bones, severe lacerations, broken teeth and significant abrasions over the majority of his body. A subsequent investigation by the West Springfield Police Department resulted in the issuance of an arrest warrant for ALI for Attempted Murder, Aggravated A&B With a Dangerous Weapon, Reckless Operation of Motor Vehicle and Leave Scene of Personal Injury Accident. ALI has ties to the greater Springfield area and a lengthy criminal record to include past convictions for multiple counts of A&B With a Dangerous Weapon, Assault & Battery on a Police Officer, and Resisting Arrest. Arrest Warrant #1923CR004600 out of Springfield District Court exists for ALI with rendition authorized in New England and New York.
